RULES AND REGULATIONS OF ENTRY

1. Individual Competitors must pay a nonrefundable \$20.00 event entrance fee that will provide admission to the Games site and admission to a fiddling workshop.

Individual competitors must include a stamped self-addressed envelope with the payment and entry form submission.

2. **ENTRIES MUST BE POSTMARKED NO LATER THAN May 5th, 2018.**
3. No person may compete in the Open or Junior divisions unless Highland Dress and a competitor number are worn. For Novice class competitors, modified concert dress is acceptable, for example, black slacks or skirt and white top. Competitor numbers are obtained at the Competition Registration table.
4. Order of Competition within Class will be determined by receipt of entry. First received will perform last, and vice versa. If a competitor is not present when his/her number is called, he/she may be subject to disqualification. The Scottish Games Association of Delaware (SGAD) reserves the right to limit the number of entries in any event. In such case, after the maximum number of entries for an event is received, subsequent entries will be returned along with the entry fee.
5. All classes of the Fiddling Competitions are sanctioned by the Scottish Fiddling Revival Ltd. Organization (SFIRE) and will conform to SFIRE's requirements and rules for sanctioned events.
6. SGAD reserves the right to cancel any event due to lack of competitors or participants.
7. Written music may be used during competition. A music stand will be provided.
8. All prize money will be mailed to competitors within about one week of the Gathering.
9. Decisions by the Steward and Judge(s) will be final.
10. Any complaints must be forwarded to the Office of the Gathering within 10 days after the Gathering along with a \$15.00 processing charge.
11. *Field entries will be taken at registration on day of competition. It would be much appreciated if you would inform the Steward of your intentions by email.*

ADVANCE SALE TICKET PURCHASE INFORMATION

NOTICE: For advance ticket sales only: Adults and children 12 and over must purchase adult entrance tickets. Children 8 -12 (\$4.00) Tickets will also be available at the gate: Adults \$20.00, Children \$6.00. Make checks payable to The SGAD. The workshops are open to all interested with no additional charge beyond admission to the Games.
